Annual Minimums: To ensure we can provide the best possible service for our stocking dealers, it is necessary that each retailer maintain a minimum annual volume of at least \$1,000 to keep their account open. Accounts will be evaluated at the end of the calendar year and those who do not meet this requirement may be deactivated. Should you find your account has not met this requirement, you will be required to re-submit an application for us to consider re-establishing your account.

Pricelist: Current pricelist in excel format may be downloaded by logging into your dealer account at <http://www.amaindistributing.com> and clicking the "Download Pricelist" link, under the My Account section of the website. Pricelists are sorted by most recently added item, with the most recently added item at the top of the pricelist. Pricelist will also be included in the monthly AMain Distributing newsletter.

Ordering: Place orders by logging into <http://www.amaindistributing.com>. The AMain Distributing website operates as a commerce platform for approved dealers. If you need any assistance or have questions regarding an order or potential order, please contact your account manager.

Shipping: Shipping will be charged on all orders under \$300. Shipping costs are immediately reflected in your online shopping cart. Orders more than \$300 qualify for free shipping. When your order reaches \$300, shipping will be immediately discounted and in most cases free for domestic orders. Some orders with large or heavy items may incur shipping fees regardless of order size.

Backorders: AMain Distributing does not require payment for backorders. We maintain a list of all products put on backorder and will notify you as soon as your backorder is available for purchase. After you receive notification that your backorder has arrived, you have seven days to log into your account and complete the purchase of your backordered products. If you do not complete your backorder purchase within seven days, your order will be cancelled.

Photography and use of marketing materials: Dealers may use AMain Distributing Photography and approved marketing materials: Dealer may use AMain Distributing Photography and approved marketing materials on any brands purchased directly through AMain Distributing. Lines not purchased through AMain Distributing are not eligible.

Warranty Information: Warranty information varies by brand and category. Warranty information for all distributed products are included in this packet. Taking care of the customer is our primary concern. If you are able, we ask that you immediately handle any valid warranty and replacement claims. If you are unable to handle a claim, please have the customer contact us.

At the end of each month we request that you contact us to process all replacement and warranty claims. We require information on all returned product and original proof of purchase. Once approved, credits will be approved within 10 business days. Please pack the items securely and do not over pack the boxes. AMain Distributing will take possession of inventory only once it has reached our warehouse docs and has been verified.

Return Process:

1. Contact AMain Distributing Returns Department to request an RMA and call tag.
2. Package the defective items.
3. Include information on each defective item.
4. Reason for Return.
5. Ship the package back to our warehouse:

Compliance with Laws: Reseller agrees that all products purchased from AMain Distributing fully comply with all applicable provisions of international, federal, state, and local laws, rules and regulations.

Indemnification: Reseller agrees to defend, indemnify and hold AMain Distributing their regents, officers, agents and employees harmless from any liability, loss or damage they may suffer as a result of claims, demands, costs or judgments against them arising out of the activities to be carried out pursuant to the obligations of these guidelines.

Map: ProTek R/C Minimum Advertised Price Policy (MAP)

ProTek R/C. ("ProTek") understands that its authorized Dealers and Resellers ("Resellers") provide end consumers of ProTek products with the kind of advice, service, knowledge, and support necessary to maintain a high level of customer satisfaction. ProTek has concluded that certain types of advertising can affect customer goodwill and can be damaging to the standards and reputation that ProTek products and your services have achieved. Therefore, ProTek has established a Minimum Advertised Price ("MAP") policy.

Objectives:

- A. To ensure that our Reseller-product relationships are consistent and value based.
- B. To maintain the proper positioning of ProTek products in the marketplace.

MAP Policy: Resellers must advertise new products at or above the minimum advertised price ("at MAP" shall include up to \$1.00 below to accommodate unique pricing conventions). The MAP is equal to the "MAP Price" displayed on our price list. The MAP is in U.S. Dollars only and all monetary values shall be the equivalent, or greater, in the current foreign currency exchange rate in place, per <http://www.oanda.com/>, on the date of advertisement. For purposes of the MAP Policy "advertising" means any advertising through authorized media. Authorized media consists of billboards, newspapers, magazines, catalogs, brochures, direct mail, retail flyers, faxes, coupons written or electronic, television, radio, any e-commerce, electronic media such as email and Facebook, and Reseller internet sites or any other method which uses the hypertext transfer protocol ("http") or any internal link to a web based shopping cart is considered advertising for the purposes of this policy. Advertising that does not state the MAP or higher price violates the MAP Policy. Any price with a "strike through" treatment is not considered a proper display of the MAP or higher price. Any advertised price, discounts such as coupons, or free accessories resulting in an effective advertised price for AMain distributed products at less than the MAP will constitute a violation of the MAP Policy. A Reseller who advertises bundles of products, which include ProTek products, must advertise the price or value of the AMain distributed products at or above the MAP. For example, the advertised bundle should say "includes ProTek product, which has a suggested retail price of \$XXXX.XX (or higher)" or words to that effect. The MAP Policy applies only to the Resellers' advertised prices, not selling prices. Resellers, Distributors, and Dealers are independently free to sell ProTek products at whatever resale price they choose.

Policy Modifications: AMain Distributing reserves the right at any time to modify, suspend, or discontinue the MAP Policy in whole or in part or designate promotional periods during which the terms of the policy change or designate periods of time during which the policy is not applicable. It shall be Resellers' responsibility to be apprised of the current requirements of the Map Policy, if any. AMain Distributing sales personnel have no authority to modify or grant exceptions to the MAP Policy or have any communications with Resellers regarding violations of the MAP Policy.

Failure to Comply: AMain Distributing will monitor compliance with this policy. It is the Resellers' responsibility to monitor its own advertisements. Violations of the MAP Policy and consequences thereof will be determined by AMain Distributing in its sole discretion. AMain Distributing may, at its own discretion, stop supplying

product to any Reseller found to be in violation of the MAP Policy. AMain has no obligation to provide prior notice or issue warning before taking action under this MAP Policy. I have read, understand, and am authorized to agree to and accept the above MAP policy.

Third Party Online Selling Restrictions: AMain.com, Inc. ("ProTek"), are the proprietary owners of the ProTek and EcoPower brands and products. AMain Distributing has been authorized by ProTek to be the exclusive distributor of ProTek brand products for North America, Europe and the UK, and the non-exclusive distributor through existing global accounts.

This exclusive distribution agreement permits AMain Distributing to market, advertise, sell, and distribute ProTek products on AMain Distributing and its affiliates' corporate and/or official websites including its authorized dealers' registered official websites.

We feel that companies like Amazon have no interest in the future growth of our brands or our industry and that short term gains distributors are gaining today by selling to and through Amazon will have negative long term implications on retailers and tracks who support new customers and longevity of our hobby. Therefore, ProTek specifically prohibits individuals or third parties, from utilizing any and all third party websites. Retailer is permitted to sell online on the Retailer's corporate brand site, but may not sell or list the Product on third party retail sites, affiliate sites, auction sites or marketplace sites, including but not limited to Amazon and eBay, without prior written authorization. Retailer must provide all website names that Retailer uses to sell Product prior to posting on the internet. It is ProTek's unilateral policy to cease supplying products to any Reseller who offers any ProTek products on internet auction sites.

Action will be taken by ProTek against violators, including but not limited to cancelling dealership, stopping online sales, and pursuing compensation for the loss caused by unauthorized sales.

Additionally, a person misusing a resale certificate for personal gain or to evade the payment of tax is liable, for each purchase, for the tax that would have been due, plus a penalty of 10 percent of the tax or \$500, whichever is more.
